## ***Rules for Reserving Clubhouse for Parties/Events***

Use of the Hammocks Clubhouse for a party or event must be arranged, in advance of the event date, with the property manager. Guests must follow all Hammocks rules (see attached). The following are rules specific to parties/events:

1. Person(s) requesting Clubhouse use must be Hammocks resident(s).
2. Parties/events are limited to 10 - 30 people
3. Parties/events will not exceed 4 hours and will end by 9 PM
4. A \$500 damage and rule adherence deposit is required in advance of the party
  - The entire deposit will be forfeited if any Hammocks' rules are broken
  - An appropriate portion of the deposit will be forfeited for any damage or excessive cleaning
  - Hammocks' management will use a checklist to determine cleanliness and damages
  - Management will determine excessive noise, disturbances, or rule violations resulting in the loss of the deposit
  - Additional charges will be required if damages exceed the deposit
  - A reservation made within 5 days of the party will require a cash deposit
  - The deposit, minus any costs listed above, will be returned, by check, to the resident within approximately 15 days of the event
5. **Rules for use** - Guests are expected to be respectful of other residents' use of Clubhouse, barbeque's, and areas around the barbecue area.
  - Reservation does not include exclusive use of the clubhouse, kitchen or barbecue facilities
  - The pool is not included in the reservation
  - No glass may be brought onto the pool deck or barbecue area. This includes drinking glasses, wine bottles, beer bottles, condiment jars and liquor or beverage bottles as well as glass or ceramic plates and bowls. These items may be brought to the clubhouse kitchen and the contents dispensed into plastic or paper cups and plates.
  - Garbage and trash must be placed in the receptacles provided. The Association property and common areas are to be kept clean, safe, and in sanitary condition. It is the responsibility of the residents and guests to clean up after themselves.
  - Parents, guardians, or childcare providers are responsible for the actions and safety of their children and any damage to the facilities caused by their children.
  - Smoking is prohibited in all of the commons facilities at The Hammocks. A designated smoking area will be provided outside the gate to the pool area.
